

# NHTSA Recalls of Interest January 13, 2025

# **Unexpected Vehicle Movement/FMVSS 114**

When the vehicle is not in "Park" and the ignition is shut off, the vehicle could move unexpectedly, increasing the risk of a vehicle rollaway and crash.

#### Summary

Nissan North America, Inc. (Nissan) is recalling certain 2025 Kicks vehicles. The "Shift-to-Park" warning may not activate as intended when the vehicle is shut off and still in a gear other than "Park." As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 114, "Theft Protection and Rollaway Prevention."

#### Remedy

Dealers will reconfigure the body control module (BCM) to activate the "Shift-to-Park" warning, free of charge. Owner notification letters are expected to be mailed January 29, 2025. Owners may contact Nissan customer service at 1-800-867-7669. Nissan's number for this recall is PMA42.

# **Rearview Camera Image May Fail/FMVSS 111**

A rearview camera that does not display an image reduces the driver's rear view, increasing the risk of a crash.

#### Summary

Tesla, Inc. (Tesla) is recalling certain 2024-2025 Model 3, Model S, 2023-2025 Model X, and 2023-2025 Model Y vehicles. The computer circuit board may short, resulting in the loss of the rearview camera image. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 111, "Rear Visibility."

#### Remedy

Tesla released an over-the-air (OTA) software update, free of charge. Tesla will also identify any vehicles that experienced a circuit board failure, or stress that may lead to a circuit board failure, and replace the affected computers, free of charge. Owner notification letters are expected to be mailed March 7, 2025. Owners may contact Tesla customer service at 1-877-798-3752. Tesla's number for this recall is SB-25-00-001.

## Summary

Aston Martin The Americas (Aston Martin) is recalling certain 2024-2025 DB12, 2025 Vantage, and 2025 DBX707 vehicles. The rearview camera image may be obstructed by the infotainment home screen menu when the vehicle is placed in reverse. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 111, "Rear Visibility."

## Remedy

The head unit software will be updated by a dealer or through an over-the-air (OTA) update, free of charge. Owner notification letters are expected to be mailed January 20, 2025. Owners may contact Aston Martin customer service at 1-888-923-9988. Aston Martin's number for this recall is RA-30-2015.
