## NHTSA Recalls of Interest

### Missing ABS Function for Trailer/FMVSS 121

Driving without a functioning anti-lock brake system may result in the trailer not braking as intended, increasing the risk of a crash.

#### Summary

Mack Trucks, Inc. (Mack) is recalling certain 2010-2018 MRU and 2019-2025 Terrapro towing vehicles. The vehicles are missing the anti-lock brake (ABS) warning light and circuitry that controls the anti-lock brake function for an attached trailer. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 121, "Air Brake Systems."

#### Remedy

Dealers will add an ABS warning light and circuitry, free of charge. Owner notification letters are expected to be mailed March 21, 2025. Owners may contact Mack's customer service at 1-800-866-1177. Mack's number for this recall is SC0474.

## Steering Gear Assembled Incorrectly

A fractured steering gear can cause the steering to bind or lock, resulting in a loss of steering control and increasing the risk of a crash.

### Summary

Ford Motor Company (Ford) is recalling certain 2024 F-150 vehicles. The steering gear assembly may have been assembled with an incorrect rack, which can cause the gears to fracture.

### Remedy

Dealers will replace the steering gear assembly, free of charge. Owner notification letters are expected to be mailed February 10, 2025. Owners may contact Ford customer service at 1-866-436-7332. Ford's number for this recall is 25S04.

## Incorrect Maximum Tire Pressure/FMVSS 139

Tires inflated to an incorrect maximum pressure may have insufficient strength, allowing the tires to fail and increasing the risk of a crash.

## Summary

Mercedes-Benz USA, LLC (MBUSA) is recalling certain 2018 E 400 Cabriolet, E 400 Coupe, 2019 E 450 Cabriolet, and E 450 Coupe vehicles. The tires were incorrectly marked with the wrong maximum inflation pressure and may not meet the strength requirements for the stated pressure. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 139, "New Pneumatic Radial Tires for Light Vehicles."

## Remedy

Dealers will inspect and replace the tires as necessary, free of charge. Owner notification letters are expected to be mailed March 18, 2025. Owners may contact MBUSA customer service at 1-800-367-6372.

## Engine Stall from Software Error

An engine stall or loss of power can increase the risk of a crash or injury.

## Summary

Honda (American Honda Motor Co.) is recalling certain 2022-2025 Acura MDX Type-S, 2023-2025 Honda Pilot, and 2021-2025 Acura TLX Type-S vehicles. A software error in the fuel injection electronic control unit (FI-ECU) may cause an engine stall or a loss of power.

## Remedy

Dealers will reprogram the FI-ECU software, free of charge. Owner notification letters are expected to be mailed March 17, 2025. Owners may contact Honda's customer service at 1-888-234-2138. Honda's numbers for this recall are EL1 and AL0.

## Rearview Camera Image May Not Display/FMVSS 111

A rearview camera that does not display an image can reduce the driver's rear view, increasing the risk of a crash.

### Summary

Honda (American Honda Motor Co.) is recalling certain 2025 Acura MDX vehicles. The touchscreen in the center console may go blank, resulting in the rearview camera image not displaying as intended. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 111, "Rear Visibility."

### Remedy

Dealers will replace the center information display unit, free of charge. Owner notification letters are expected to be mailed March 3, 2025. Owners may contact Honda's customer service at 1-888-234-2138. Honda's number for this recall is RKZ.

## Water Intrusion In Harness Can Shut Down EV System

A loss of drive power increases the risk of a crash.

**Manufacturer** Mitsubishi Fuso Truck of America, Inc.

**Potential Number of Units Affected** 233

### Summary

Mitsubishi Fuso Truck of America, Inc. (MFTA) is recalling certain 2024 FEC7K and FEC9K trucks. The chassis harness may have been improperly sealed. Water intrusion can shut down the EV system, causing a loss of drive power.

### Remedy

Dealers will repair the chassis wire harness and replace the fuse terminals as necessary, free of charge. Owner notification letters are expected to be mailed February 21, 2025. Owners may contact MFTA customer service at 1-877-711-0707. MFTA's number for this recall is C10129.

## Driver's Air Bag May Not Deploy/FMVSS 208

A deactivated driver's air bag will not deploy as intended, increasing the risk of injury during a crash.

**Manufacturer** Toyota Motor Engineering & Manufacturing

**Components** STEERING, AIR BAGS

**Potential Number of Units Affected** 1,716

### Summary

Toyota Motor Engineering & Manufacturing (Toyota) is recalling certain 2023 Toyota Corolla, Corolla Cross, Corolla Cross Hybrid, Highlander, Highlander Hybrid, Tacoma, Lexus RX350, 2023-2024 NX250, and NX350 vehicles that may have been incorrectly repaired under previous NHTSA recall number 23V-480. An electrical connection inside the steering column's spiral cable assembly may be insufficiently welded, causing the connection to separate and deactivate the driver's air bag. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard number 208, "Occupant Crash Protection."

### Remedy

Dealers will inspect and replace the spiral cable assembly as necessary, free of charge. Owner notification letters are expected to be mailed March 30, 2025. Owners may contact Toyota's customer service at 1-800-331-4331. Toyota's number for this recall is 25TA02. Lexus' number for this recall is 25LA02.
